### PROCEDURE

1. Begin installation by working on driver side of the vehicle starting at the front of the inner rocker panel.
2. Located on the inside as well as the bottom inner of the rocker panel you will see one thread hole and one thread stud for each mounting bracket refer to diagram 1.(Note all brackets are labeled )
3. Install mounting brackets to inner rocker panel using 8mm 1.25 x 25 mm bolts plus 8mm nuts and washers as shown in diagram 2.Hand tighten only.
4. Attach side bar to brackets using the 3/8" button head bolts and washers. Align the side bar with the vehicle body, then tighten & torque all fasteners to: (30ft/lbs). Repeat steps for passenger side to complete installation.
