- 1) Raise vehicle on a hoist or safety stands to provide access to the exhaust system.
- 2) Loosen the bolts at the flange of the catalytic convertor and pry the hanger pin from the hanger.

**HINT: Unhook some or all exhaust hangers to help with removal.**

- 3) Remove the clamp securing the turbo down pipe to the turbo outlet and remove pipe. Separate the pipe assembly.

**\*\*CAUTION\*\* BE SURE TO SUPPORT THE CATALYTIC CONVERTOR IF NOT REMOVING IT. CONVERTOR IS HEAVY AND DAMAGE AND/OR INJURY MAY RESULT.**

**NOTE: If not installing a pyrometer, secure plug in turbo outlet pipe.**

- 4) Position the new down pipe on the outlet of the turbo and install clamp loosely to hold pipe in place (you will need to twist pipe slightly while installing other components). If more clearance is required, bend back the lip of the firewall and floorboard.
- 5) Position the flange gasket over the end of the down pipe and install the convertor inlet pipe. Connect all support hangers and position pipes for proper clearance from underbody components.
- 6) Tighten exhaust clamps at turbo outlet and pipe joints.
- 7) Start engine to check for leaks and exhaust components touching frame or underbody structures. Loosen clamps and adjust as required to seal leaks and maintain clearance, then secure clamps.
