


Tools Needed Alcohol and Clean Cloth Pencil


Step One

Open the door. Use a clean cloth to clean the area in the bottom of the door opening with alcohol.

Place an Entry Guard in the door opening and align it as desired. Use a pencil to mark the position of the rear edge of the guard. Remove the guard from the vehicle and peel the backing off the adhesive (2 places). Replace the rear edge of the Entry Guard on the pencil mark and press the guard into position on the vehicle, working from the rear to the front. Rubthe guard to make sure the adhesive attaches securely to the vehicle.

Repeat this procedure on the other side of the vehicle.
