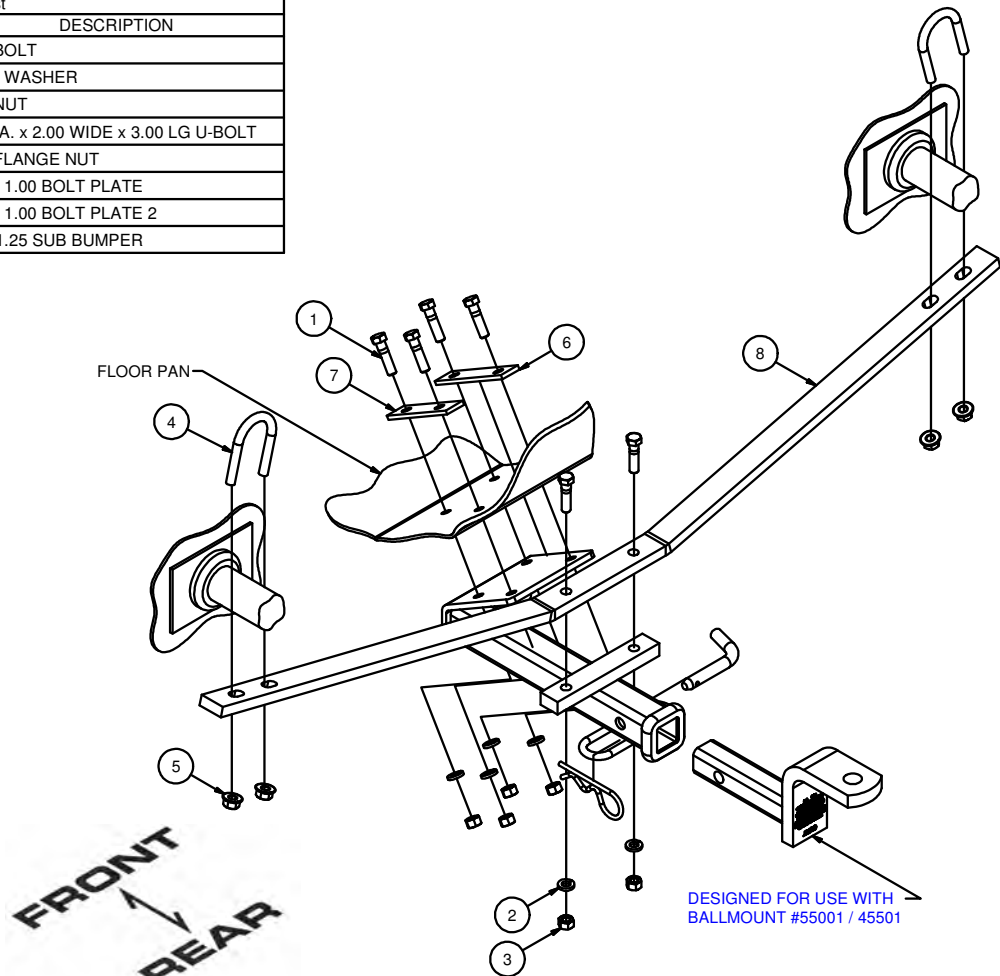

INSTALLATION STEPS

1. This hitch includes a sub-bumper (approx. 45" long steel bumper) supporting the hitch under the car's bumper struts.
2. Install the sub-bumper under the car's tubular bumper struts as shown in the diagram. Do not completely tighten them at this time.
3. Fasten the hitch receiver to sub-bumper using fasteners as shown. Adjust the sub-bumper fore / aft on the struts until the angle bracket on the hitch meets the car floor pan (adjacent to the car's tie down loop). Tighten all the lock nuts at the struts to be snug. Mark the floor pan four places for angle bracket holes and drill the pan for 3/8" diameter screws. NOTE: Remove the contents from the trunk near the area where holes will be drilled, and drill holes.
4. Install the hitch at the sub-bumper using fasteners as shown. Install the hitch at the car's floor pan with backing plates placed inside the trunk; opposite the hitch.
5. Torque all 3/8" fasteners to 45 lb-ft.

PERIODICALLY CHECK THIS RECEIVER HITCH TO ENSURE THAT ALL FASTENERS ARE TIGHT AND THAT ALL STRUCTURAL COMPONENTS ARE SOUND.
