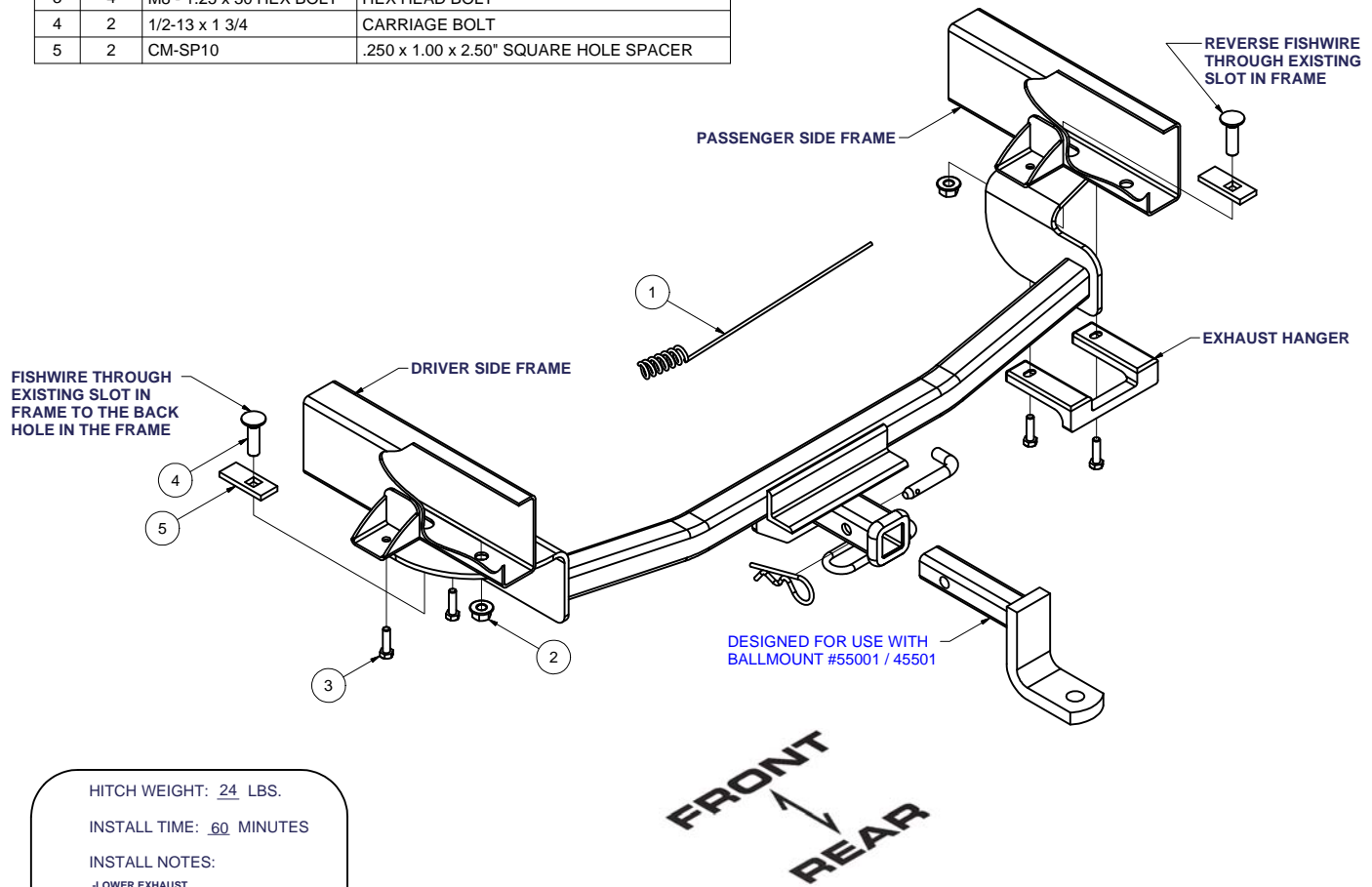

**INSTALLATION STEPS**

- 1) Lower exhaust on driver side, passenger side(remove exhaust hanger), and center of vehicle.
- 2) Remove heat shield, trim off wings and front lip. Re-attach with four existing fasteners.
- 3) Fishwire 1/2" carriage bolts and SP-10 spacers to proper locations on driver and passenger side frames.
- 4) Lift hitch into position to mark where receiver tube hits bumper fascia. Trim bumper fascia to fit.
- 5) Lift hitch and exhaust back into position at the same time. (Note: Once hitch is mounted the exhaust can not be lifted back into place). Attach with 1/2" flange nuts and to existing weldnuts with M8 bolts (4).
- 6) Tighten all 1/2" hardware to 75 ft-lbs and all M8 bolts to 17 ft-lbs.
- 7) Raise exhaust back into position.

PERIODICALLY CHECK THIS RECEIVER HITCH TO ENSURE THAT ALL FASTENERS ARE TIGHT AND THAT ALL STRUCTURAL COMPONENTS ARE SOUND.
