

## **INSTALLATION STEPS**

- 1. Locate the vehicle's frame rails under the rear of the vehicle. These are located above the muffler on the driver and passenger sides.
- 2. Remove the rear bolts in the bottom surface of the frame rails on each side. Return these parts to the vehicles owner for reinstallation should the hitch ever be removed. Access to remove the passener side bolt may be easier if the exhaust hanger is temporarily removed.
- 3. Position the hitch on the vehicle, and mount to frame rail through existing weldnuts using fasteners as shown.
- 4. Using the hitch as a template, mark the bumper box beam for (4) holes. Remove the hitch from the vehicle and centerpunch and drill the holes for 1/2" diameter bolts through the bottom of the bumper box beam.
- 5. Install one rectangular U-bolt in each set of holes in the bottom of the box beam. Reposition the hitch on the vehicle being careful to not push the U-bolts out of the box beam. Fasten the hitch to the vehicle using fasteners as shown.

  NOTE: Do not use impact wrench on U-bolts.
- 6. Torque all 12mm fasteners to 86 lb-ft, and all 7/16" fasteners to 70 lb-ft.

PERIODICALLY CHECK THIS RECEIVER HITCH TO ENSURE THAT ALL FASTENERS ARE TIGHT AND THAT ALL STRUCTURAL COMPONENTS ARE SOUND.
