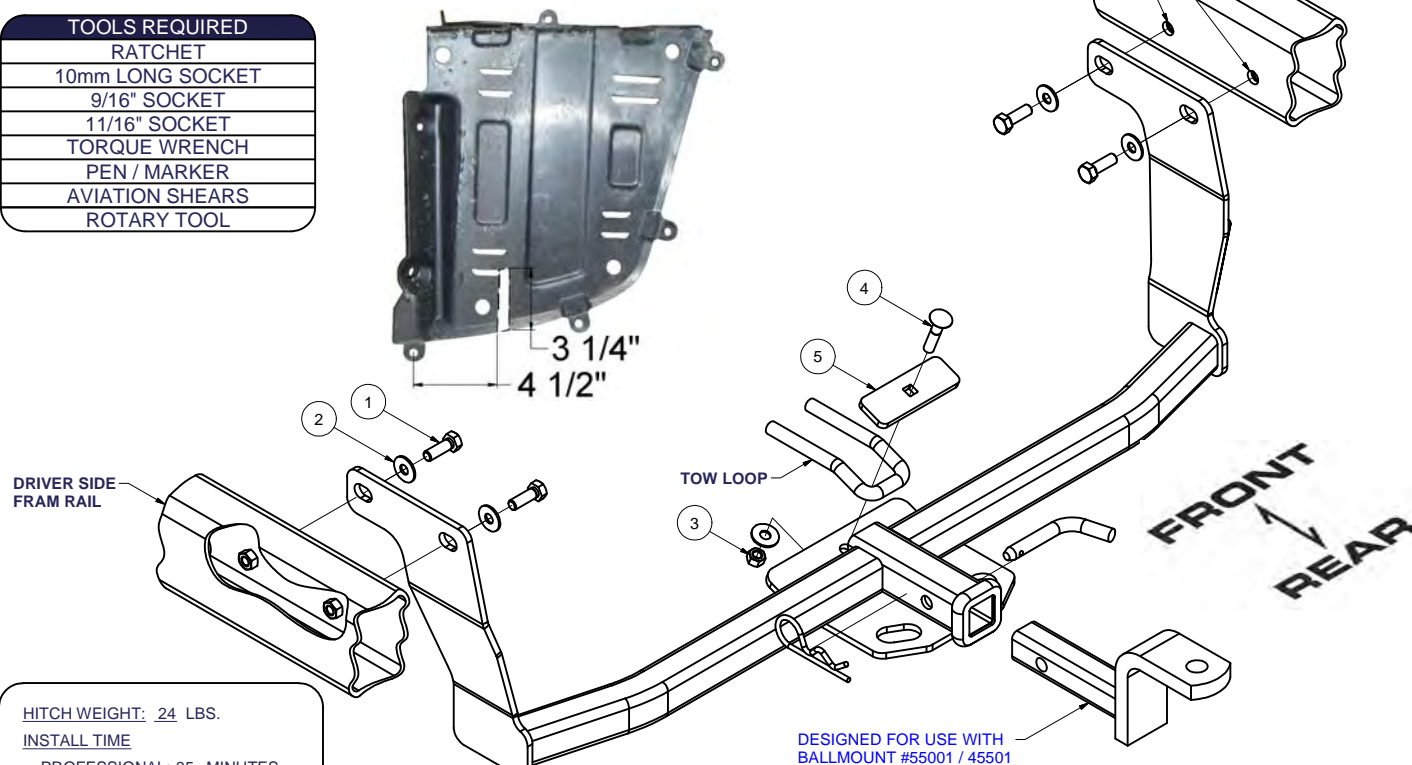

INSTALLATION STEPS

1. Remove plastic underbody panel (8) fasteners, if needed.
2. Remove the passenger side muffler heat shield by first removing the two rearmost muffler mounts. This will allow access to the four heat shield mounting fasteners and then the forward-most frame weldnut.
3. Place rectangular spacer with 3/8" carriage bolt through tow loop. Raise hitch into position over existing muffler heat shield(s). Notch bumper fascia as needed on drivers side.
4. Install 10mm fasteners on each side into existing weldnuts in the frame rails. Install 3/8" conical toothed washer and 3/8" nut through hitch plate and secure to hitch.
5. Torque all 10mm fasteners to 37 ft-lbs, and all 3/8" fasteners to 30 ft-lbs.
6. Trim and reattach plastic underbody panel as shown, if needed.

PERIODICALLY CHECK THIS RECEIVER HITCH TO ENSURE THAT ALL FASTENERS ARE TIGHT AND THAT ALL STRUCTURAL COMPONENTS ARE SOUND.
