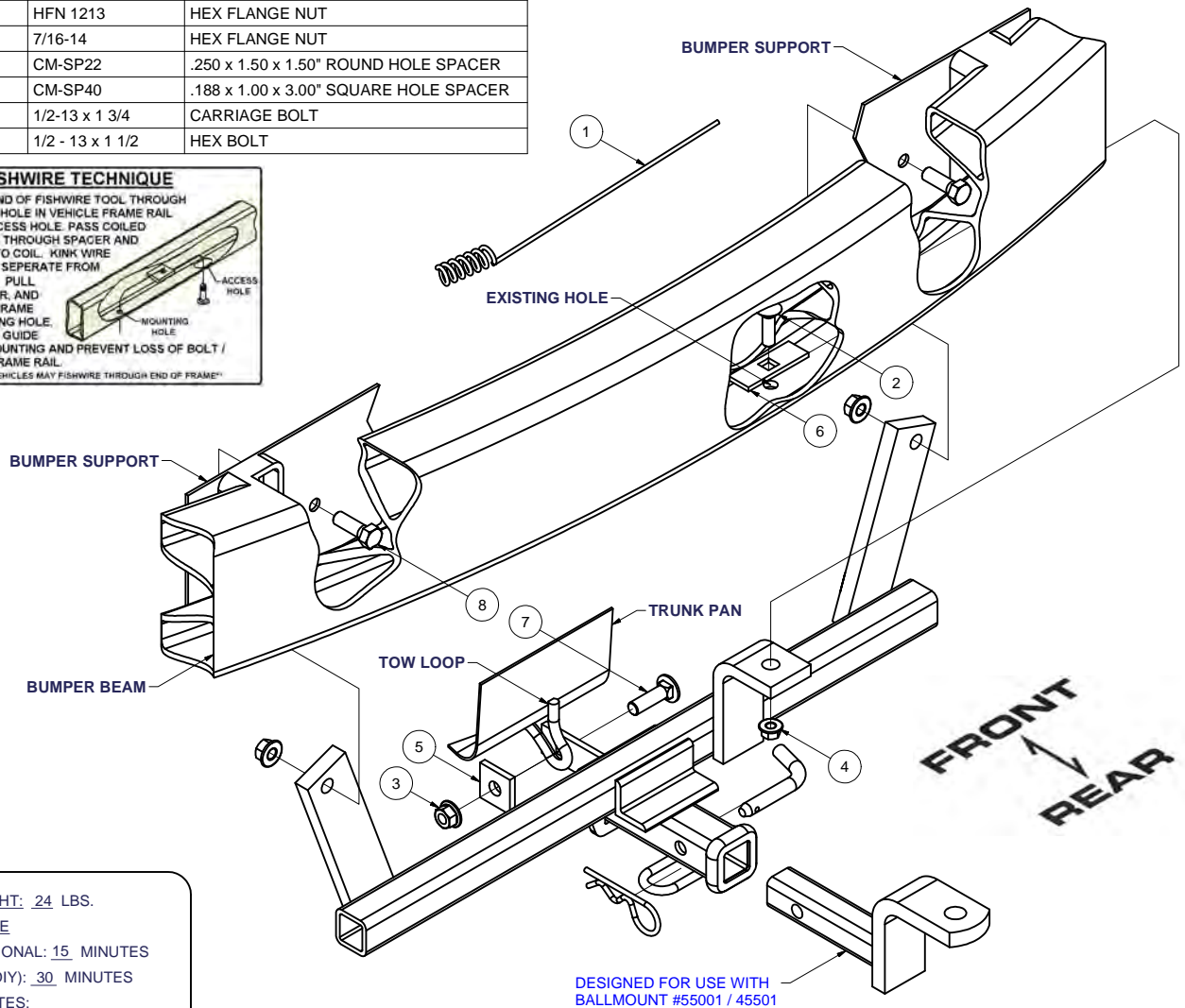
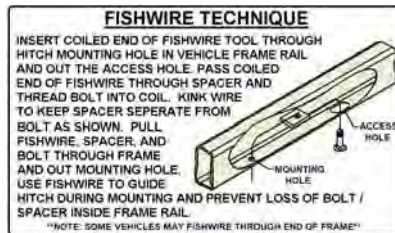

INSTALLATION STEPS

- 1) Fishwire 7/16" carriage bolt and spacer through end of bumper beam and out existing hole as shown.
- 2) Raise hitch into position and secure with 1/2" hex bolts, flange nuts and 7/16" flange nut, finger tight.
- 3) Secure hitch to tow loop using 1/2" carriage bolt, spacer, and flange nut as shown.
- 4) Torque all 1/2" fasteners to 75 lb-ft. and all 7/16" fasteners to 50 lb-ft.

PERIODICALLY CHECK THIS RECEIVER HITCH TO ENSURE THAT ALL FASTENERS ARE TIGHT AND THAT ALL STRUCTURAL COMPONENTS ARE SOUND.
