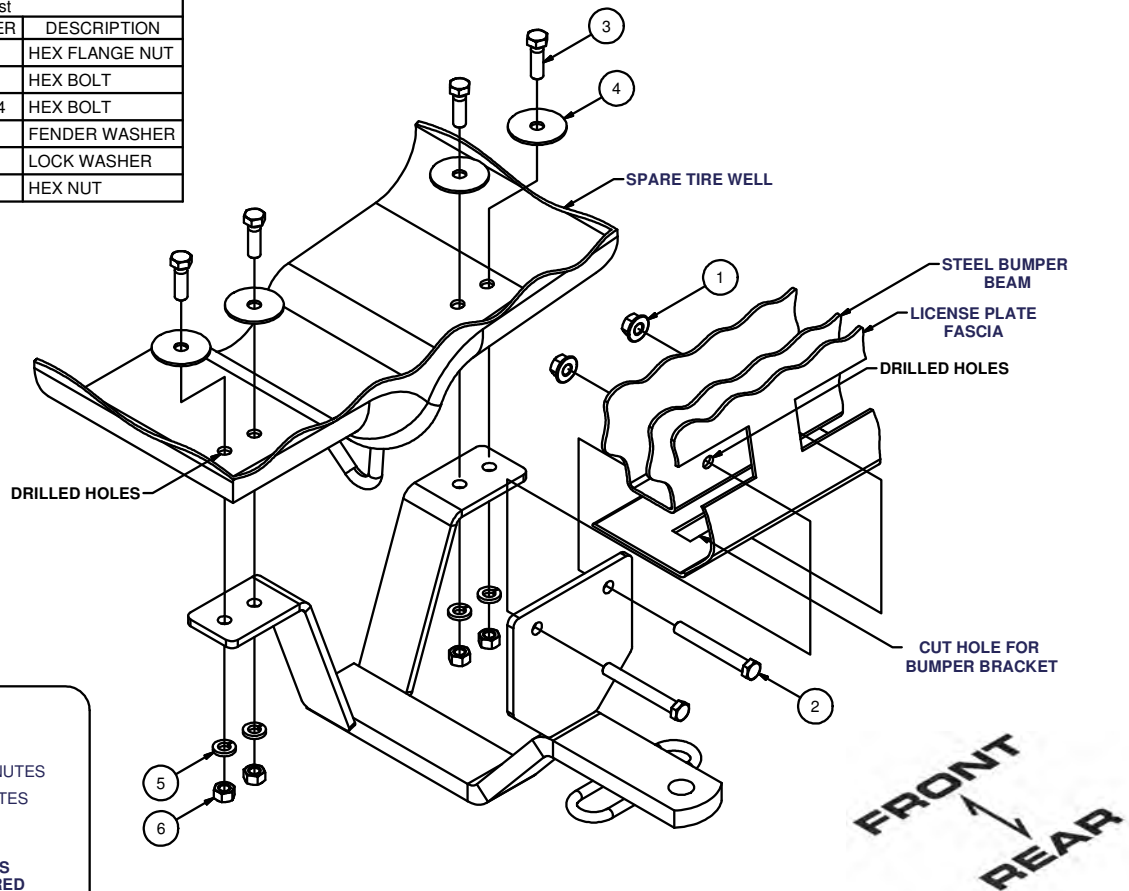

INSTALLATION STEPS

1. Locate and mark the vehicle's centerline on the rear steel bumper beam (visible in license plate area). Clear all contents in the trunk where the floor holes will be drilled.
2. A slot approximately 1/2" x 5 1/2" must be cut into the license plate fascia using a sharp utility knife. Locate the slot to fit the hitch bumper plate through the slot.
3. Raise hitch into position, center and square with the vehicle. Using the hitch as a template, mark and centerpunch the bumper beam (2) places and spare tire well (4) places for the hitch fasteners.
4. Drill the holes for 3/8" diameter fasteners.
5. Install the hitch using fasteners as shown above. Notice fender washers are placed inside of the vehicle, opposite the hitch. Tighten the lock nuts only until the bumper beam starts to compress.
6. Torque all 3/8" fasteners to 45 lb-ft.
7. Silicone seal hardware that is installed through spare tire well.
8. Reinstall contents removed in Step 1.

PERIODICALLY CHECK THIS RECEIVER HITCH TO ENSURE THAT ALL FASTENERS ARE TIGHT AND THAT ALL STRUCTURAL COMPONENTS ARE SOUND.
