

**INSTALLATION STEPS**

1. Temporarily remove rear license plate. Hitch bumper plate will bolt to vehicle's rear bumper beam in license plate recess area. Hitch chassis bracket bolts to vehicle's floor pan. Be certain to clear trunk before drilling.
2. Locate vehicle's center line at rear bumper and support hitch on vehicle centered and square. Using the hitch as a template, mark, centerpunch, and drill bumper and trunk for 3/8" diameter mounting bolts. Drill 1" access holes as shown to install handle nuts.
3. Bolts attaching the hitch bumper plate to rear bumper are placed so tab nuts are inside of the bumper. Fasten hitch to vehicle floor with washers placed as shown.
4. Silicone around fasteners in trunk pan to prevent water and exhaust fumes from leaking into vehicle.
5. Torque all 3/8" fasteners to 45 ft-lbs.
