INSTALLATION STEPS

- 1) Remove all fasteners which hold the inner and outer bumper brackets to frame.
- 2) Loosen, but do not remove the bolts which hold the outer bumper brackets to the bumper. Slide the outer bumper brackets away from the frame.
- 3) Position the hitch over the frame, lining up the holes and slots in the hitch with the bumper bracket mounting holes in the frame.
- 4) Loosely install the existing fasteners through the hitch, frame and inner bumper brackets.
- 5) Slide outer bumper brackets back into position. The hitch should be sandwiched between the outer bumper brackets and the frame.
- 6) Install the remaining fasteners
- 7) Tighten fasteners at frame commection to 110 ft-lbs.
- 8) Tighten fasteners at outer bumper bracket bumper connections.

PERIODICALLY CHECK THIS RECEIVER HITCH TO ENSURE THAT ALL FASTENERS ARE TIGHT AND THAT ALL STRUCTURAL COMPONENTS ARE SOUND.
