

## **INSTALLATION STEPS**

## **DODGE CHASSIS CAB**

- 1. Remove rearmost rivet on bottom of frame rail, each side. (Rivet location will be enlarged in Step 3.)
- 2. Raise hitch into position, place rear edges of horizontal flanges flush with end of frame rails and clamp to frame rail.
- 3. Using hitch as a template, drill 3 holes on each side as shown.
- 4. Install carriage bolts and spacers through holes drilled in frame rails and out hitch side plates, as shown above. Secure with flange nuts.
- 5. Torque all 9/16" hardware to 150 ft-lbs.

#### **CHEVROLET/GMC CAB & CHASSIS**

- 1. Raise hitch into position by aligning 1" diameter hole with the rivet on the bottom of the frame rail, on each side and clamp in place.
- 2. Using hitch as a template, drill (3) holes on each side as shown.
- 3. Install carriage bolts and spacers through holes drilled in frame rails and out hitch side plates, as shown above. Secure with flange nuts.
- 4. Torque all 9/16" hardware to 150 ft-lbs.
