WARNING! Breaking in an engine with ceramic-coated headers WILL result in damage to the coating and will VOID all

warranties. Ceramic-coated headers require several heat cycles to fully cure before they will withstand extreme heat. HOOKER recommends using a cast-iron exhaust manifold or an old header to break in new

engines to avoid coating damage.

NOTE: P/N 16520HKR dual exhaust system was designed to be used with Hooker Competition Headers - P/N 2451HKR If

the dual exhaust is being installed with headers other than P/N 2451HKR, modifications will be required. Hooker will

not assume responsibility for fit or performance.

NOTE: P/N 16619HKR will not fit stock manifolds that exit straight down.

NOTE: Mufflers are not supplied with this exhaust system. Hooker Headers has designed this kit for use with Hooker Turbo

muffler P/N 21005HKR, 21105HKR, or any equivalent 2 1/4" I.D. inlet by 2 1/4" I.D. outlet single offset OEM muffler.

Glasspack mufflers may be used with slight modifications.

NOTE: If your wheelbase is greater than 132", tailpipe extensions are required to provide proper tailpipe exit. Order


extensions from local muffler shop.

BEFORE STARTING:

Your vehicle must be raised a minimum of 36 inches. A floor hoist is ideal. If no hoist is available, we strongly urge the use of axle stands as a safety measure. **CAUTION!** Your car should **NOT** be supported on a bumper jack! We recommend welding all pipe slip joints (headpipe to muffler, etc.). If no welding equipment is available at the time of installation, use the furnished clamps to secure the pipes until they can be welded.

INSTALLATION PROCEDURE - PLEASE READ CAREFULLY:

- Remove the existing headpipe, crossover, and the single exhaust. Save old gaskets and sleeves from the stock exhaust headpipes.
- Install the new headpipe front sections, using the old gaskets and sleeves and headpipe extensions. Tighten only enough
 to hold in place. On header duals, install the front header extensions to the collectors, using the new gaskets provided. DO
 NOT TIGHTEN.
- 3. Install mufflers, tailpipes, and all hangers. DO NOT TIGHTEN. See Figure A.
- 4. Hangers are to be located as follows: The first to be installed in the first inside bolt hole of the OEM muffler bracket (both sides). The next is to be installed in the front bolt hole of the OEM tailpipe hanger on the outside3 of the frame behind the rear wheel. See **Figure B**.
- 5. Cut the end of the tailpipes to desired length.
- 6. Make sure that all parts of the system are clear of frame members, all hoses, suspension, and brake lines. Starting at the headers, tighten all connections, making sure all parts are clear and will not leak or rattle.
- Start the engine and check for leaks. Be sure that all brake lines, fuel lines, and electrical wires have sufficient clearance. Reroute, as necessary.
- 8. When finished, give your car a test drive, checking carefully for any new noises. After several days of driving, retighten all the bolts.
