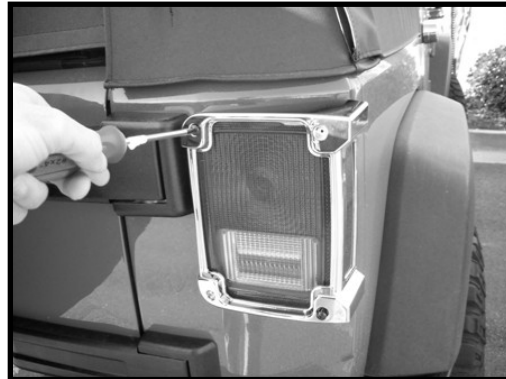


## 07+ JK Tail Light Trim

1. Identify the left and right tail light trim pieces by locating the **L** or **R** molded inside each trim piece.
2. Locate the four tail light screws on the driver side tail light. Remove the top right and bottom left screws. Place the tail light trim piece labeled **L** over the driver side tail light and replace the screws. Tighten evenly.



3. Locate the four tail light screws on the passenger side tail light. Remove the top left and bottom right screws. Place the tail light trim piece labeled **R** over the passenger side tail light and replace the screws. Tighten evenly. Be sure the tail light trim is securely fastened to the vehicle before operating.
