

UTV Clamp on Side or Rear View Mirror (1.5" - 1.75" Tube ID)

Contents: (1) 5" Round Mirror Head

(1) Adjustable Metal Clamp with

foam padding.
(1) Hex Head Bolt

(1) Flat Washer (1) Lock Washer



- 1. Please read instructions fully prior to installing mirror. It is important to locate the mirror in a spot that allows for rear viewing but does not impede the safe operation of the UTV.
- Mirror may be mounted over the front center bar as a center rear view mirror or may be mounted to front A-pillar roll cage bars (left or right) as a side view mirror. Each UTV will be slightly different regarding location.
- 3. Unscrew hex bolt, flat washer and lock washer from mirror head and retain for reinstallation.
- 4. Slide clamp over 1.5" 1.75" ID tube with flat surface of clamp pointing in direction mirror will be facing.
- Reinstall Hex head bolt with washer through the back side of the clamp and tighten using 10mm wrench.

Final adjustment of mirror can be made by unscrewing the three Phillips head screws located on the back side of mirror until head can be moved. When in desired location retighten the three screws.
