Step 1: Locate the two plastic inserts in each corner of the bumper opening, remove and discard. This will expose a factory mounting location behind the bumper on both sides. **NOTE:** The mounting locations will be a round or oval hole through a metal plate on both sides. (Fig A)

<u>Step 2:</u> Match up the light bar brackets to the factory mounting holes through the bumper. Next, start a 1/2" x 5/8 bolt, 15/16 nut, and 2" washer and hand tighten. Repeat on other side. Installation is now complete.

CARE AND MAINTENANCE

To protect your investment it is recommended to regularly wash and wax this part. Do not use any type of cleaners that contain abrasives that may damage the finish of your part.
