


INSTALLATION INSTRUCTIONS

WARN WINCH CARRIER KIT NO. 62027 For use with Trans4mer Mounting Systems & Winches up to 16,500 lb.

CAUTION: When mounting a Warn 15,000 or 16,500 lb. Winch, be sure the Trans4mer Grille Guard for your truck is also certified for the capacity of that winch. Some versions are limited to 12,000 lbs. only.

1. Install the Carrier between the side members as shown in **Figure 1**. Use the black bolts with the black side members. Special fasteners are provided in the stainless steel kits.

- 2. If a front license plate is required in your state, it can be attached at the holes provided in the lower stiffener plate of the Carrier.
- 3. Install the fairlead (included with the winch) onto the front of the Carrier using the lower winch mounting bolts.
- 4. Complete the winch installation as directed in the Winch Installation Instructions. The lower grille guard tube cannot be installed with some of the larger winches. After tightening the forward four bolts, it is very important that the two additional bolts extending up into the bottom of the winch are also installed. Use the supplied flat washer's to fill any space between the Carrier and the winch.

NOTE: When installing the Warn 12,000 winch, the Control box may interfere with the top edge of the carrier bracket. If this happens, loosen the band clamps that surround the motor, push the box toward the center of the winch and rotate backward slightly to gain clearance. The stiff electrical cables attached to the motor may resist this movement, but they can be forced into a new position. When installing the Warn 15,000 winch the control box can be adjusted to the rear using the slotted holes in the bracket. The Warn 16.5ti control pack cover is also slotted for adjustment fore and aft.

IMPORTANT: Many vehicles require extra braces when the Carrier is installed. These are packaged with the Trans4mer Kit for the particular make of vehicle. Instructions for installing the braces are also included with the Trans4mer Kits.



ONE YEAR LIMITED WARRANTY

Warn Industries warrants each new Warn product specified above against factory defects in material and workmanship for one year after date of purchase. The owner will be responsible for removing from the vehicle and returning any defective item(s), transportation costs prepaid, to Warn Industries Service Department or a factory authorized servicing distributor. Warn Industries will, without charge, repair or replace at its option, products or product part(s) which its inspection determines to be defective. Such item(s) will be returned with transportation costs prepaid from the service point. A copy of the purchaser's receipt must be returned with the defective item(s) in order to qualify for warranty coverage. Exclusions from this warranty are the finish and any condition(s) determined by Warn Industries to have been caused by abnormal use or service. This warranty shall not apply to any Warn product specified above which has been improperly installed.

There are no warranties, expressed or implied (including any implied warranties of merchantability and fitness), which extend beyond this warranty period. The loss of use of this product, loss of time, inconvenience, commercial loss or consequential damages are not covered. Warn Industries reserves the right to change the design of any product without assuming any obligation to modify any product previously manufactured.

This warranty gives you specific legal rights. You may also have other rights which vary from state to state. Some states do not allow limitations on how long an implied warranty lasts. Some states do not allow the exclusion or limitations of incidental or consequential damages. Therefore, the above limitation(s) or exclusion(s) may not apply to you.
