

Installation Tips

Before you begin installing this assembly, read all instructions thoroughly.

For a smooth fit:

For ease in installation, the product should be installed at temperatures above 72° F. Below this temperature, the fabric may contract an inch or more, making it difficult to fit to the vehicle. It is normal for fabric to contract and wrinkle when stored in the shipping carton. Within a few days after the installation, the fabric will relax and the wrinkles will disappear.

CAUTION Safety glasses should be worn at all times while installing this product.



Floor Mounting

Bracket, Lt., Qty - 1

Remove the Existing Rear Seat

Remove the old rear seat. Remove the existing front mounting brackets. Discard the brackets, but set the bolts aside to be used to install the new seat.


WARNING

If your vehicle has carpet covering the floor, cut the carpet so that the Floor Mounting Brackets are installed flush on the metal floor. If the Floor Mounting Brackets are not flush mounted, the seatback may not lock in place, which could

result in serious injury to you and others.

Left Floor Mounting Bracket Installation 2

Locate the Left Floor Mounting Bracket with the cutout toward the front of the vehicle. Align the holes in the bracket with the holes behind the seat riser in the vehicle. Use two of the original bolts that were removed in Step 1 to install the Floor Mounting Bracket. Securely tighten the bolts.




Failure to install the E-Clip may result in the seat moving off the Front Brackets which could result in serious injury to you and others.

Slide Seat onto Left Front Mounting Bracket

Orient the Seat, with the Legs on the bottom of the seat facing the rear of the vehicle. Fold the Seat back down into the closed position. Place the Seat in the vehicle

Locate the pivot pin on the front left side of the Seat. Slide the pin into the hole in the Left Front Mounting Bracket. Slide an E-Clip over the pin so that it catches in the notch in the pin.





Install Right Front Mounting Bracket

Orient the Right Floor Mounting Bracket with the cutout toward the front of the vehicle and slide it over the pivot pin on the front right side of the seat. Secure the bracket to the seat with the remaining E-Clip. Align the holes in the bracket with the holes in the floor. Use the two remaining original bolts that were removed in Step 1 to install the Floor Mounting Bracket. Securely tighten the bolts.



Install Right Front Mounting Bracket on Seat with E-Clip





5 Install Striker Plate

Remove the Seat Belt Mounting Bracket and set it aside to be reinstalled.

Orient the Striker Plate with the raised catch toward the rear of the vehicle. Place the plate in the vehicle with the middle hole over the hole from the seat belt bracket and the catch toward the rear. Re-place the Seat Belt Mounting Bracket on top of the Striker Plate and align the hole in the bracket with the middle hole in the plate. Re-install the bolt to secure the Seat Belt Mounting Bracket and the Striker Plate.

Tumble the Seat back and hook the lock on the rear of the seat to the catch on the Striker Plate.
