





TrekStep Side-Mount[™] – Installation Instructions




Install U-Nuts

Install the M10 U-Nuts in the mounting holes.




4 Install Linkage

Place the 2" x 2" Spacer between the Frame Mount and the Linkage. Use two (2) M10-1.5 x 90mm Hex Bolts and M10 Washers to mount the Linkage and Spacer to the Frame Mount. Use the two (2) mounting holes closest to the cab.




3 Install Frame Mount

Align the holes in the Frame Mount with the U-Nuts. Use four (4) M10-1.5 x 45mm Hex Bolts and four (4) M10 Flat Washers to secure the mount to the frame.



5 Install Step

Use the M6-1.0 x 20 Socket Head Cap Screws to mount the Step to the Linkage Assembly.





6 Step Adjustment

Once the Step is installed on the vehicle, you may adjust it as desired.

If necessary to adjust the height, use the two (2) 1/4" Spacers provided. Remove the M10-15 x 45mm Hex Bolts installed in Step 4 and place the 1/4" Spacers between the Frame Mount and the Linkage. Reinstall the Hex Bolts.

When the Step is in the desired position tighten all nuts.



Operation

- The TrekStep[™] is foot operated and deploys and retracts with a nudge of your foot.
- To deploy, press down using your foot, on the forward outside corner of the step pad.
- To retract, gently kick the underside of the step pad.
- Max Load Capacity: 400 lbs.
- Always use appropriate hand holds when stepping up to or down from your truck's cargo bed.

Care and Maintenance

The step pad surface and linkage arms should be washed with mild soap and water using a soft brush or sponge to dislodge any mud, dirt or accumulated road grime. Rinse with fresh water. After it is dry, lubricate the hinge with 3-IN-ONE Oil. To prevent slipping, avoid applying waxes, lubricants or protectants like Armor All® to the step surface.

TrekStep[™] SHOULD ALWAYS BE STOWED IN THE RETRACTED POSITION WHEN DRIVING.
