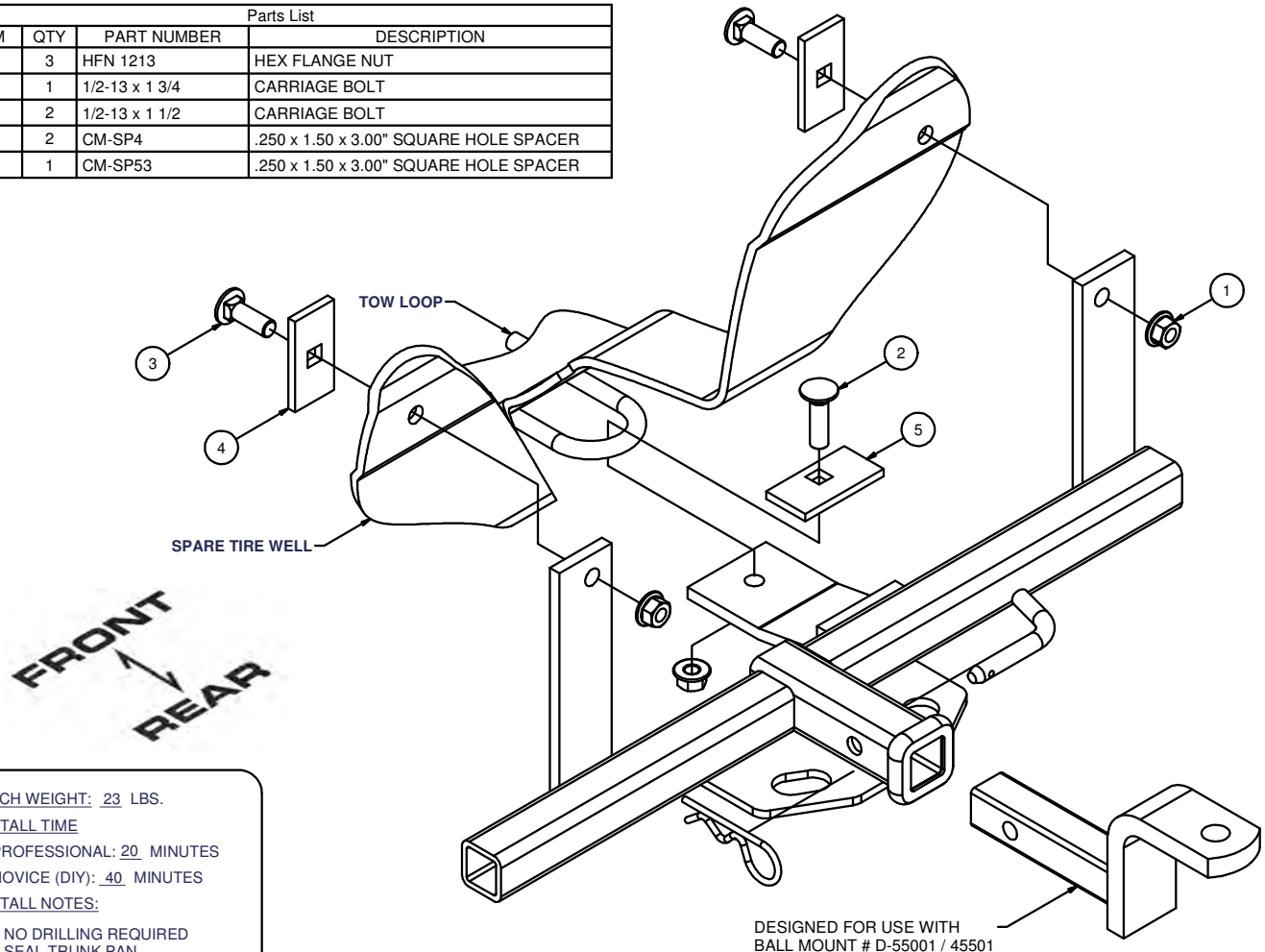

INSTALL NOTES:

- SEAL TRUNK PAN

INSTALLATION STEPS

- 1) Remove trunk insert.
- 2) Remove (2) trunk body plugs.
- 3) Place 1 3/4" carriage bolt into large square hole spacer.
- 4) Fit carriage bolt and spacer into tow loop (as shown).
- 5) Lift hitch into position and fasten to tow loop using 1/2" flange nut.
- 6) Push carriage bolts into spacer and through the trunk pan. Fasten hitch to bolts with flange nuts.
- 7) Torque all 1/2" fasteners to 110 lb-ft.
- 8) Seal trunk, using silicone caulk around interior flange nuts.

PERIODICALLY CHECK THIS RECEIVER HITCH TO ENSURE THAT ALL FASTENERS ARE TIGHT AND THAT ALL STRUCTURAL COMPONENTS ARE SOUND.
