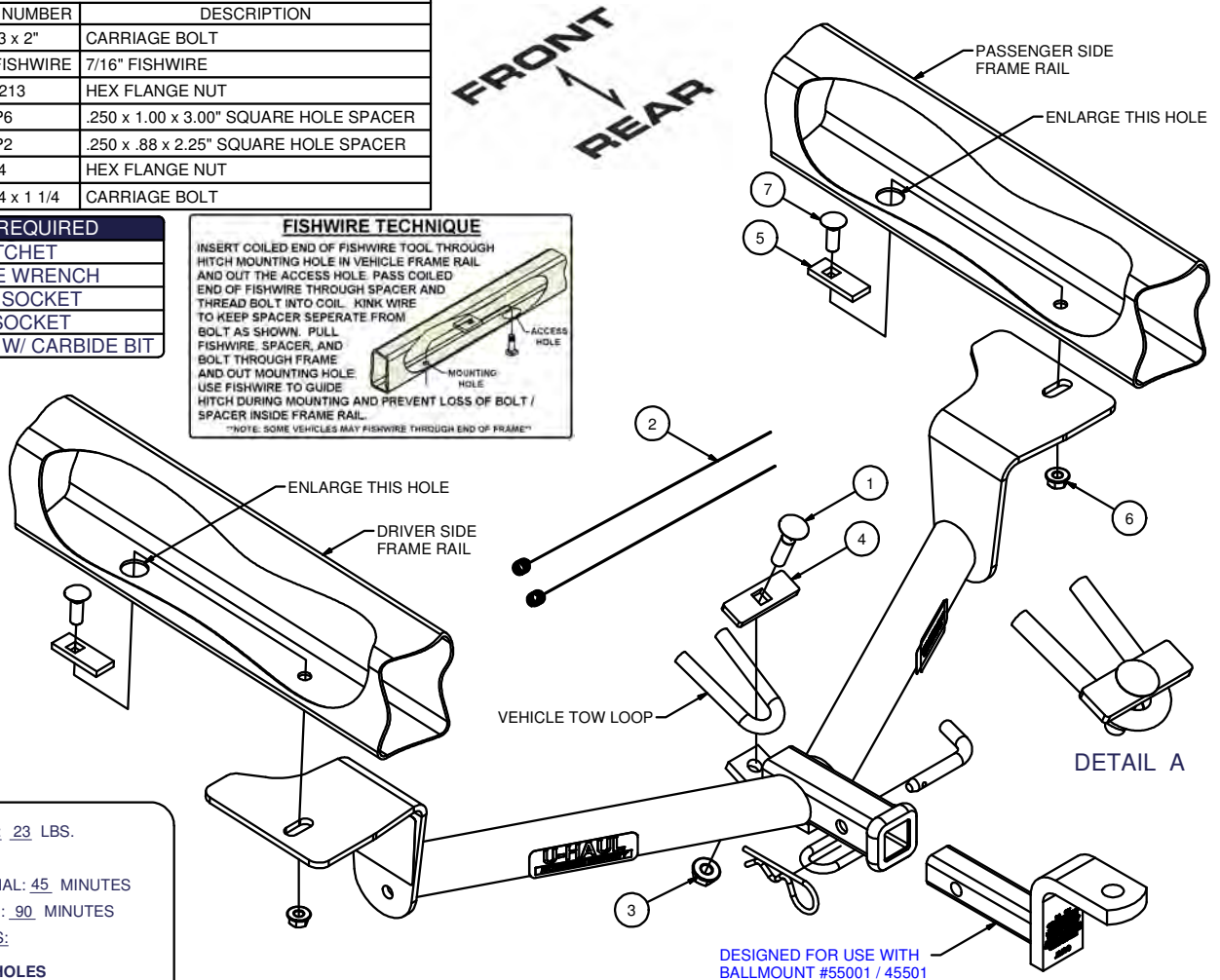
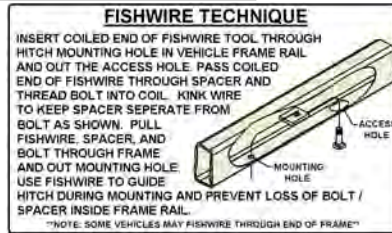

**INSTALLATION STEPS**

1. Using the die grinder and carbide bit, enlarge the middle hole in both frame rails to allow for the CM-SP2 spacer and 7/16" carriage bolt to pass through.
2. Fishwire the 7/16" carriage bolts and CM-SP2 spacers into position as shown in the diagrams above. Leave the fishwires attached to the bolts.
3. Position the 1/2" carriage bolt and CM-SP6 spacer in tow loop as shown in DETAIL A.
4. Thread the fishwires through the holes in the hitch and raise hitch into position above the exhaust tail pipe. Loosely install the 1/2" hex flange nut at tow loop mount.
5. Remove the fishwires and install remaining flange nuts.
6. Torque all 7/16" fasteners to 70 lb-ft, and all 1/2" fasteners to 110 lb-ft.
