


**INSTALLATION STEPS**

1. Remove rear bumper, fasteners are located inside the trunk at either side against the rear wall, one of which is located under a plastic floor plug. Also remove screws holding the bumper cover to the vehicle at the wheel wells.
2. Remove tow hook. Return tow hook to vehicle owner.
3. Bolt the hitch to the (3) holes that are in the bumper as shown. Final tightening of these bolts must be done before the bumper is reinstalled on the vehicle. There is no clearance after the bumper is reattached. Torque M10 hardware to 35 lb-ft.
4. Reinstall bumper, but do not tighten hardware. The two holes in the bottom plate of the hitch should line up with weldnuts in the brackets under the back of the vehicle. Adjust bumper to align hitch with weldnuts. Install hardware through the hitch into the vehicle.
5. Tighten all bumper attaching hardware. Torque remaining M10 hardware to 45 lb-ft.
