

INSTALLATION STEPS

-I OWER EXHAUST

Note: For dual exhaust systems repeat steps for both sides.

- 1) Lower the exhaust system by unbolting the M8 exhaust hanger/bumper bracket bolts. Note: Make sure to support the bumper, do not remove inboard top M8 bolts at this time.
- 2) Loosely reinstall only the existing M8 bolts(s) through the outboard weldnut(s).
- 3) Remove the remaining inboard bumper bracket bolts, and discard the four existing M8 bolts.
- 4) Fishwire 1/2" carriage bolt and SP17 spacers through large slots.
- 5) Raise hitch into position and loosely install M8 fasteners provided, through blocks, hitch, and bumper brackets, into the existing weldnut.
- 6) Install 1/2" flange nuts onto carriage bolts that were fishwired in step 4.
- 7) Disconnect hanger bracket(s) from exhaust system(s), modify exhaust hanger bracket(s) by cutting inboard side of crossmember.
- 8) Reinstall exhaust system(s) to hanger brackets and install exhaust hanger fasteners.
- 9) Torque 1/2" fasteners to 110 LB.-FT., 3/8" fasteners to 45 LB.-FT., and M8 fasteners to 23 LB.-FT.

PERIODICALLY CHECK THIS RECEIVER HITCH TO ENSURE THAT ALL FASTENERS ARE TIGHT AND THAT ALL STRUCTURAL COMPONENTS ARE SOUND.
