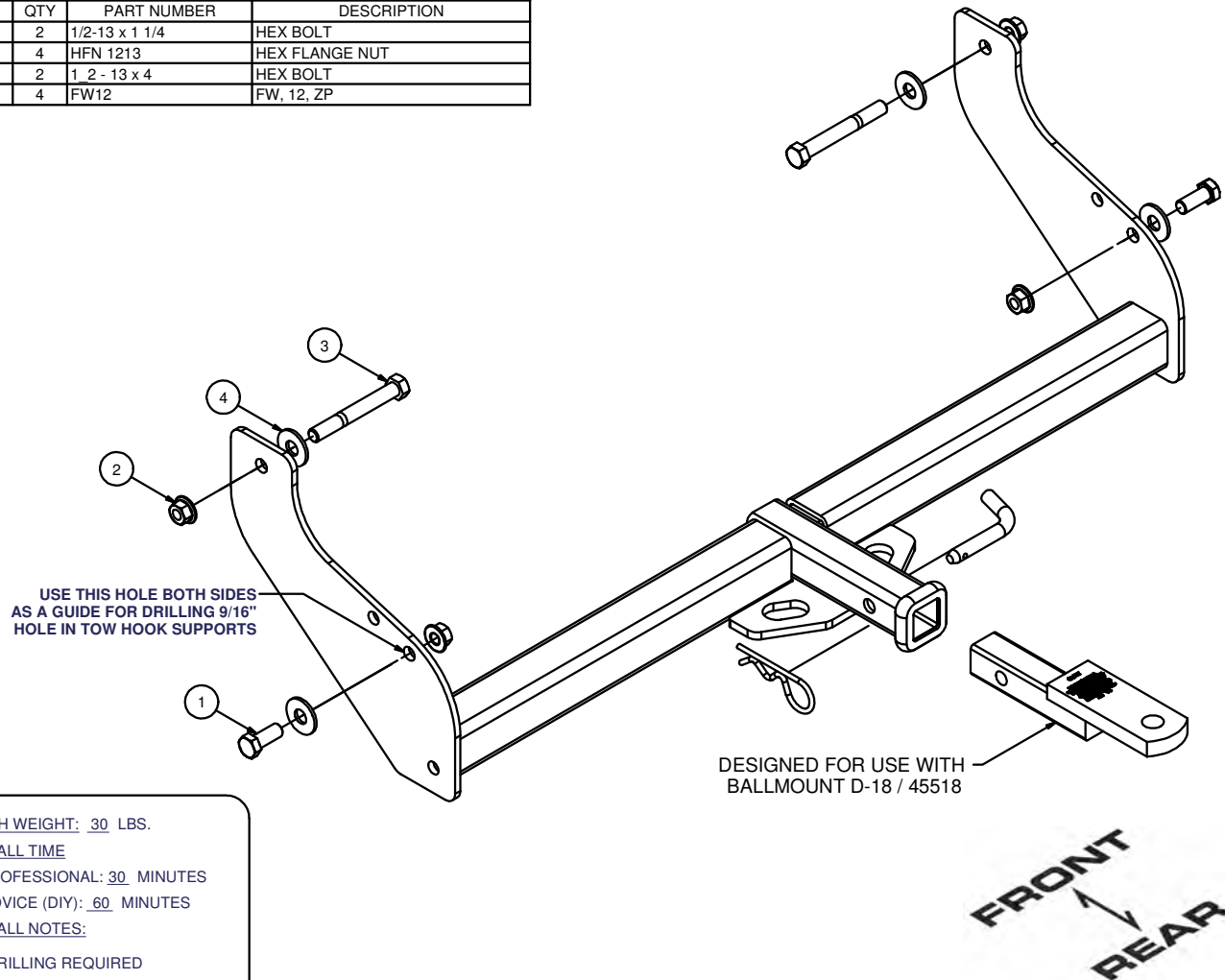

## INSTALLATION STEPS

- 1) RAISE THE HITCH UP TO THE FRAME AND INSTALL A 1/2" HEX BOLT THROUGH THE REARMOST HOLE OF THE HITCH (Both sides) AND THRU THE EXISTING FRAME SLOTS.
- 2) ATTACH THE HITCH WITH THE 1/2" FLANGE NUTS, FINGER TIGHT ONLY.
- 3) ROTATE THE HITCH UPWARD TO A LEVEL POSITION AND CLAMP IT TO THE TOW HOOK SUPPORTS.
- 4) WHEN THE HITCH IS LEVEL AND PROPERLY POSITIONED USE THE HOLE IN THE HITCH MOUNTING PLATE AS A GUIDE AND DRILL A 9/16" HOLE THROUGH THE TOW HOOK BRACKET. (Both sides)
- 5) AFTER DRILLING THROUGH THE TOW HOOK BRACKETS INSTALL THE 1/2" HEX BOLTS AND WASHERS AND ATTACH WITH 1/2" FLANGE NUTS.
- 6) TORQUE ALL 1/2" HARDWARE TO 110 FT/LBS.

**PERIODICALLY CHECK THIS RECEIVER HITCH TO ENSURE THAT ALL FASTENERS ARE TIGHT AND THAT ALL STRUCTURAL COMPONENTS ARE SOUND.**
