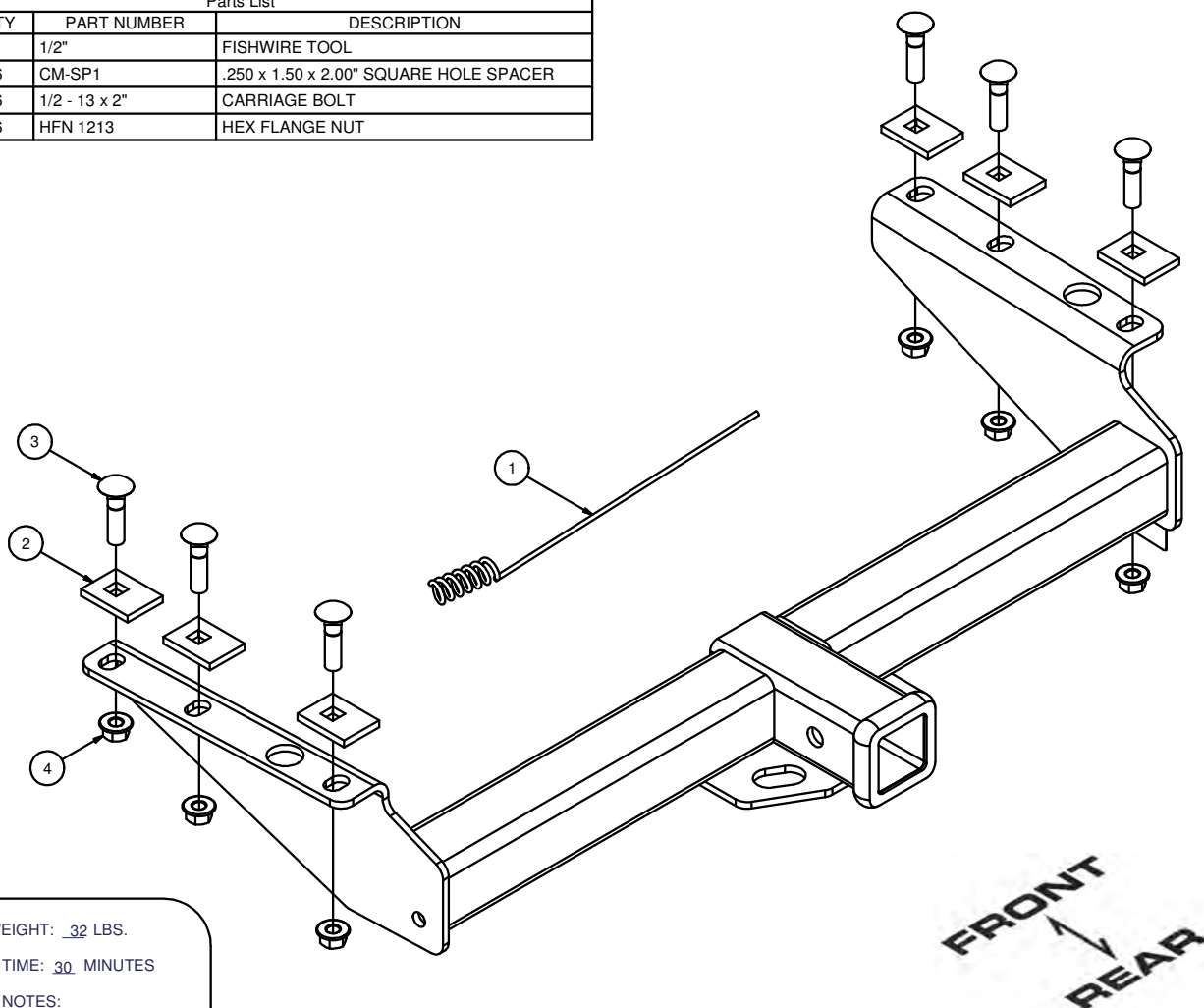

INSTALLATION STEPS

- 1) **Place carriage bolts and square hole spacers** through existing holes in frame rails. (Some models may require mounting holes to be reamed out to allow for a 1/2" fastener.)
- 2) **Installations on boxed-in frames** will be made easier by fishwiring the bolts and spacers into the holes from an exiting access hole. Wrap a wire around the threads of the bolt at the end and pull wire, bolt and spacers back through the access hole through the attachment hole.
- 3) **Raise hitch into position**, taking care not to push bolts back into frame. The large slot on each side fits over the rivet. Secure each bolt with a flange nut.
- 4) **Torque** all mounting bolts to 110 lb-ft. using a torque wrench.

PERIODICALLY CHECK THIS RECEIVER HITCH TO ENSURE THAT ALL FASTENERS ARE TIGHT AND THAT ALL STRUCTURAL COMPONENTS ARE SOUND.
