INSTALLATION INSTRUCTIONS FOR NP98-32/ Oe38-32/ SL68-32/ SP88-32/ TR48-32

Thank you for purchasing one of our fine quality products. Your seat cover is engineered from high quality materials and designed with precision to give you a long-lasting, well-adjusted fit.

A) BACKREST COVER

- 1) Remove headrests. (see note below)
- 2) Slip cover over backrest and pull down firmly (see airbag warning below)
- 3) Tuck flaps under backrest and attach to velcro at back
- 5) Replace headrest (see note below)

5) Pass long side strap through the opening between

the seat and the molded plastic and under the seat

7) Adjust straps to equalize to equalize tension

4) Adjust velcro to equalize tension

B) <u>CUSHION COVER</u>

1) Move seat to most forward and uppermost position

2) Place cover on seat cushion ensuring long side strap is on the door side

3) Pass back flap of cover with straps through crevice

4) Feed straps under seat and buckle to front of cushion cover

1) SELF-LOCKING SUPER-GRIP® BUCKLE:


3) RE-INSTALLATION OF HEADRESTS A) Ensure pre-cut holes in seat cover align with holes

- in headrest base.
- B) Replace headrests

6) Buckle to the other side

2) HEAD REST REMOVAL:

Push in side release buttons - Lift off (If unable to remove consult dealership)



WARNING: DO NOT BLOCK AIR BAGS

WHEN INSTALLING SEAT COVERS:

Seats with integrated seat airbags must be covered only with seat covers designed with openings. Make sure that the openings in the sides of the seat covers are positioned so that the seat covers do not block or interfere with the deployment of the air bag. The attached flap tucks inside the cutout and should be able to open freely in case of deployment.
Constantly check your seat covers to ensure they are properly positioned to allow for complete air bag deployment.
