Thank you for purchasing one of our fine quality products. Your seat cover is engineered from high quality materials and designed with precision to give you a long-lasting, well-adjusted fit.

## A) CUSHION COVER

- 1) Move the seat to most forward and uppermost positions
- 2) Place cover on seat cushion ensuring long side strap is on the door side (see note below)
- 3) Pass back flap of cover through crevice
- 4) Feed straps under seat and buckle to front of cushion cover (see note below)
- 1) Remove headrest (see note below)
- 2) Slip cover over backrest and pull down firmly (see air bag warning below)
- 3) Pass straps through crevice and under backrest
- Feed straps under seat and buckle to front of cushion (see note below)

2) HEAD REST REMOVAL:


Press in side release buttons

# 3) RE-INSTALLATION OF HEADRESTS

- Ensure pre-cut holes in seat cover align with holes in
- base.
- Replace headrests

**4) DUE TO RESTRICTED SPACE UNDER CUSHION**, a  $2^{\circ} \times 30^{\circ}$  piece of cardboard with 2 slits at one end will simplify the placing of the straps. If desired, the strip can be cut from the seat cover box.



## WARNING: DO NOT BLOCK AIR BAGS WHEN INSTALLING SEAT COVERS:

1) Seats with integrated seat airbags must be covered only with seat covers designed with openings. Make sure that the openings in the sides of the seat covers are positioned so that the seat covers do not block or interfere with the deployment of the air bag. The attached flap tucks inside the cutout and should be able to open freely in case of deployment.

2) Constantly check your seat covers to ensure they are properly positioned to allow for complete air bag deployment.

- B) BACKREST COVER
  - 4) Feed straps under seat and buckle to front of cushion (see note be low)
  - 5) Apply Velcro on cover to carpeting on bottom back of seat

5) Pass the side strap through the opening between the seat

6) Adjust straps and velcro to equalize tension
